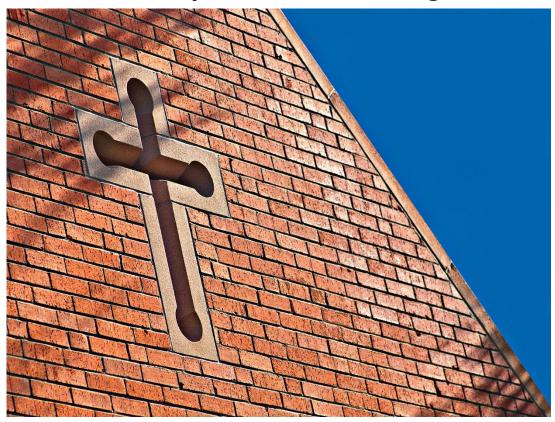

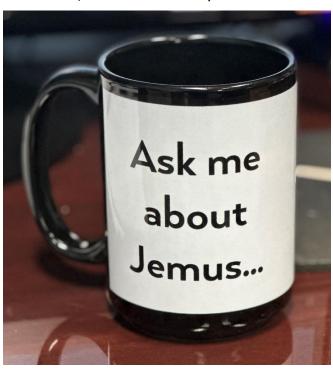

## 2023 Annual Report – Chris Campbell, Lead Pastor

2023 was a great year for FPCA! Below I will mention a few highlights that stand out to me. But something that needs to be included in the official record is that our Texas Rangers are World Series champions! Do you believe in miracles?!

The year contained all the ordinary ebbs and flows of the church: babies were born; young couples were married; new members joined; good friends moved away; and beloved saints joined the Church triumphant. And in every one of those circumstances, FPCA was there to display the love of Christ.

Preaching series began with one on renewal in January; DTR (Define the Relationship) around Valentine's Day; The Lent Experience; Easter Close Up; and the BELIEVE generosity campaign. But the series that seemed to resonate with so many people was the longest of them all, 14 in total, on the 12 disciples. That was such a rewarding deep dive.



It also provided my most infamous slip of the tongue while preaching on James the Less. It is thought that this James looked very similar to Jesus and that people sometimes confused the two. And I combined the two and invented the name Jemus. Thanks to a very hilarious Christmas present, I will never forget it or live it down...

The other moment that made a great impression on me was the Sunday we hosted the teens and leaders from the Ulster Project. It was such a treat

for our family to be able to visit Northern Ireland last summer and tour the still segregated communities within Belfast – where most of these teens live. Their presence and participation are visible signs of what peacemaking genuinely looks like. Obviously, deep-rooted division and hatred does not disappear overnight. But this ministry is working to do that. I'm honored we were able to host the protestant worship service and have a great lunch with them.

Thank you to everyone who makes FPCA such a wonderful place to worship, grow in discipleship, and passionately serve this community of Arlington, Tarrant County, and to the ends of the earth.

## 2023 Annual Report – Jim Shroyer, Parish Associate

2023 was my second year as this church's parish associate. The year seemed to fall into two parts: January and June through December and February through May. The division fell into when my wife Jamee's health was bad and when her health was good.

When her health was bad - pneumonia in both lungs, a long hospital stay, kidney damage, dialysis - I told Pastor Chris I regretted I couldn't do much for the church. He said, "Don't worry about your time. Just take care of Jamee right now, and come back when you can."

Sometime in May, Jamee began seeing improvement, and soon that became dramatic improvement. She graduated from dialysis, then from home health care. In November, Jamee's kidney doctor said she has never seen anyone get better as fast and as thoroughly as Jamee.

My point is this: I have many thanks to give. I thank Pastor Chris for giving more grace than I ever expected, and I thank you, this congregation, for the same. You really are an exceptional church family, and you all, every one, have put yourselves in the midst of an exceptional church family. I thank God for upholding Jamee and me: our discouragement in the bad times was less than it might have been for someone lacking Christian faith. And I thank God for showing – again - that his grace and power are more than we might expect or might have any right to. I thank all of you - and many, many others - friends of Jamee's over many years in lots of places - for your faithfulness in prayer for her. She has been keenly aware of being lifted up in prayer and aware of the power of prayer in this healing.

So, I hope that my good 2023 months have contained some good pastoral work and made some people's lives better. In 2023, I made 285 pastoral visits, served 12 home communions, led three Sunday services at FPCA and one at another church, co-taught five classes, led or co-led four funeral/memorial services, led one Town Village devotion, led one service for renewal of marriage vows, and participated in one Cameroonian wake.

When all is said and done, I count it all as joy.

#### **Requests for Funds Received**

We received four requests that were approved for recommendation to the Session. All requests were approved by Session, through the budgeting process, as follows:

 Discipleship Team - to help pay for summer camp expenses like camp registration, fees, food, gas for vans, van rental, lodging, etc.

Approved: \$3,900 from the Schrickel Youth Development fund and \$1,400 from White Family Scholarship

2. Mission/Evangelism Team - to provide funds for Adrian Rodriguez to support his seminary studies

Approved: \$2,000 from the Kurz Scholarship Fund

3. Mission/Evangelism Team - to support outreach with Presbyterian Children's Home and Services (PCHAS) by holding the annual event/outing (breakfast, lunch, and UTA game) with children and youth from PCHAS

Approved: \$1,400 from the Robert Malcolm Dawson Memorial Fund

4. Discipleship Team - Funds to be used to help pay for special events like lock-ins, paintball, food, supplies, and registration and/or event payments

## **Online and Social Media Ministry**

In 2023, our ministry accomplished great things. Glory be to God! We've completed the switch to livestream to the Fellowship Hall, both on Facebook and YouTube.

On YouTube alone, our content was watched 1,300 hours last year, a 13% increase from the past 365 days. We have also seen a 41 increase in our subscribers; that's 265% more than the past year. People from all over the world were able to worship with us (or at least get to know our church).

On Facebook, we were able to help the Children's Ministry by bringing the community together to our events like Trunk or Treat and Kids Night Out. We also livestream our services on Facebook, giving people the option to worship when they are traveling or out of town.

Thanks to you and your faithful support, both our social media have been growing. This helps us to spread the Word and spread the Gospel. On those two media, we have an average of 30 people worshiping every Sunday and coming back to watch and worship at the recorded service.

As I write this, we're working hard to improve our software capability and functionality so those who worship and watch online can have a better and smoother experience.

I also want to thank our youth volunteers; they make a huge difference in this ministry. Thank you, FPCA!

#### **Trustees**

The trustees receive, hold, encumber, manage, and transfer property, including restricted and unrestricted funds, following the approval of the congregation, and subject to the authority of the Session.

This year, Trustees Judy Northup, Kathy Moore, and Ron MacLeod reviewed quarterly performance of the long-term investments entrusted to Texas Presbyterian Foundation (TPF). Trustees reviewed asset allocation to assure that invested funds were in line with FPCA investment policy. During the first quarter of 2023, a total of \$7,347, representing a 2% Session-approved 2022 distribution, was transferred to funds available for use by FPCA. For the year 2023, trustees recommended, and Session approved, a minimum distribution

of 3%. This distribution will be made in the first quarter of 2024, based on performance through December 31, 2023.

TPF investments reflect the following change in long-term investments for the year 2023:

- \$360,146 December 31, 2022
- \$421,845 December 31, 2023

Fixed assets totaled \$5,538,409 as of December 31, 2022, and \$6,203,969 as of December 31, 2023. A Long-Term Assets Summary 2023 is included as part of this Annual Report.

The trustees reviewed and updated the Corporate Resolution Regarding Bank, Brokerage, and Investment Accounts with the current officers in March 2023, and subsequently updated signatories at Chase Bank, Texas Presbyterian Foundation, and Charles Schwab accounts. A Form 802, Periodic Report of a Nonprofit Corporation, was also filed with the Secretary of State.

Trustees also reviewed and executed contracts and legal documents on behalf of FPCA. Contracts over \$25,000 included review and coordination with our law firm, Middlebrook | Group, PLLC. In 2023, such documents included proposals/contracts for:

- Oxley Architects, PLLC, for the detailed drawings and design work related specifically to the replacement of ceilings and lighting fixtures required to be done in conjunction with the asbestos abatement and fire suppression system (sprinkler) installation that will be done by Goff Construction
- Crux contract for security officer services
- Termination of Blue Line contract, original architect contract for Transform project
- FSG Facilities Lighting Group contract for external lighting replacements
- Goff Construction GMP (Guaranteed Maximum Price) contract
- DFW Abatement Services Consulting for asbestos abatement review and reporting
- E-Logic for the asbestos abatement removal
- Ownership and Funding form for the Goff Construction contract

#### **Finance**

The operating budget for 2023 was adopted as a balanced spending and income budget of **\$1,063,470**. It was based on pledges and historical giving estimates, along with the use of temporarily restricted funds either on hand or raised during the year. The budget plan included the expectation of total general fund revenue contributions and miscellaneous income of \$976,080, designated funds income of \$34,430, and use of Session and spendable restricted fund use of \$52,960.

As shown in the financial reports included with this report, the total general fund revenue contributions and miscellaneous income was \$933,931, and designated funds income of \$12,616. Total general fund and designated income was \$946,548. Session and restricted funds used to achieve the balanced year-end budget were only \$92,551 for a total income for 2023 of **\$1,039,098**.

Thanks to outstanding team management of our resources throughout the year of all the many expenses needed to operate the church - which is roughly \$3,000 per day – total expenses for 2023 were \$1,050,721. The difference is offset by non-annual income adjustment for the roof loan payment.

Total non-annual expenses were \$260,233. This includes the roof loan payments and ongoing Transform construction and installation costs.

The Presbyterian Investment and Loan Program (PILP) loan from the Presbyterian Church (USA), totaling \$374,668, was used to repair the roofs and steeple that were damaged during a 2018 hailstorm. This loan is 3.5% for 20 years. The PILP loan balance as of December 2023 was \$343,728.

In 2023, the Transform capital campaign fund received contributions of \$242,035 and the Transform capital campaign funds used in 2023 was \$236,038, leaving a balance of \$1,510,351 in the capital campaign fund as of December 31st.

## Women's Ministry

One of the goals set by the Women's Ministry Team is to serve Christ by leading women to a closer relationship with Him. To that end, the team held an in-person brunch on January 28, 2023, designed to help women develop the spiritual discipline of worship. The event was the fourth in the "New Year, New Beginnings" series, which has the intent of diving into a different spiritual discipline each year. Martita Lynch, from Gateway Church in Grand Prairie, returned to teach on this topic.

Continuing to explore the discipline of worship, after Easter, a 6-week Bible study began, called "Attributes of God," so attendees could learn about who God is, and the depth of His character, as a means of getting to know the One who we should love and worship above all.

For the fall study, a virtual 6-week Bible study was kicked off on September 19, 2023, titled "More Than Anything." It explored the topic of idolatry, and allowed attendees to ponder the question of whether we love God more than anything. Through this study, we learned about what happens when the things of this world, that compete for our attention and hearts, become substitutes for the one true God, and how to put God in the rightful place He deserves within our hearts.

The final Women's Ministry Team gathering of the year was an in-person Advent Kickoff Party, held on December 5, 2023. Women of the church gathered to enjoy a hot chocolate bar, sweet treats, and a wonderful time of fellowship and Christmas bingo. Attendees received a copy of *The First Songs of Christmas* devotional, to enjoy throughout the Advent season.

### **Adult Ministry**

Six adult classes meet weekly on Sunday morning. Class members also gather to serve dinners at the Life Shelter, help at the Mobile Food Pantry, and support other community outreach efforts. Many classes also attend events together - enjoying fellowship outside the church.

#### **Bible Study Class**

The Bible Study Sunday school class studies through one book of the Bible at a time, meeting weekly to discuss one chapter per week. We are a loving, diverse group of Christians that meet to jointly study God's word and support one another through prayer and fellowship. During 2023, our class finished our study of Romans. We then proceeded to study the Gospel of John, Hebrews, and Exodus.

We welcome drop-ins and those who are available for limited periods of time. We open each class by sharing our joys and concerns so that we may pray for one another. Prayer is followed by time in the Word as we share the insights we've gained through our study of Scripture during the week.

In addition to Bible study on Sunday morning, the class prepares a dinner in December for the clients at the Arlington Life Shelter. If you are looking for a Sunday School class, we would love to have you join us! For more information, please contact Suzie (817-271-5995).

#### **Family Living Class**

The class continues to use the International Uniform Lesson curriculum with rotation teaching leaders.

Attendance averages about 20 to 27 weekly. Our class regularly meets on occasions other than Sunday for shared meals, fellowship, and cultural activities. The class strongly supports multiple service opportunities such as Arlington Life Shelter, Mission Arlington, H.O.P.E. Tutoring, and New Day. We are grateful for having a long and enduring group relationship within our class to lift one another up when needs arise.

#### **Foundations Class**

The Foundations Class had a great year! We continue to include attendees virtually while most of us gather in person. It has been especially wonderful to have Matthew and Theresa Lee attend regularly while they serve in Cameroon. 2023 studies included N.T. Wright's Bible studies on the Gospel of Luke and the book of Acts. In addition, we gather to celebrate birthdays and other fun social events.

#### **Friendship Class**

The Friendship Class is a welcoming group of adult singles and couples that meet in room 214, where we share our joys, concerns, and gratitude as we study God's word each Sunday at 9:45.

In 2023, our class contributed to Arlington Charities, Arlington Life Shelter, One Great Hour of Sharing for earthquake victims in Syria and Turkey, provided snacks for VBS, and donated to Embrace Grace.

Presently, the Friendship Class is studying Charles Stanley's book 30 Life Principles. During 2023, we benefited from David Jeremiah's study guide/DVD format of Powerful Principles from Proverbs and A Life Beyond Amazing (fruits of the Holy Spirit). In the coming months, the class will consider The World of the End: How Jesus' Prophecy Shapes Our Priorities.

Social fellowships were held in March, May, and December as we gathered in member's homes to continue having fun and sharing with Christian friends.

The Wednesday Women's Bible Study, formerly Monday Night Women's Bible Study, meets the second Wednesday of each month, except for the summer, at 1 p.m. in the church parlor.

In May, the group finished their 2022-2023 study and voted to move the date and time of our Bible Study to daytime on the second Wednesday of each month, excluding summer months. With many of the members either feeling uncomfortable or no longer able to drive at night, the group voted unanimously to make the change.

The Horizon's Presbyterian Women's curriculum is used each year. In September 2023, the group began the new study *Sacred Encounters*, a study of Luke. All women are invited and can join at any time.

This group rotates facilitators and takes turns bringing a light snack.

The distribution of children's books was continued at Trunk or Treat, and almost all the books were given away to the families attending the event. The group also provided a meal for the Arlington Life Shelter.

#### **Team Focus**

The focus in 2023 of the Mission and Evangelism Team was continued growth and ministry in Local, National, and International Missions.

#### **Team Goals for 2023**

- Increase participation in Local Missions.
- Continue to help FPCA to grow as a missional church.
- Continue relational evangelism and to spread God's Word.

### **Local Ministries**

#### **Arlington Life Shelter (ALS)**

FPCA continues to assist the ALS with various needs annually, including funding. Six FPCA Sunday school classes/groups (Genesis, Women's Bible Study, Loose Ends, Family Living, Cameroon Women's Fellowship (CWF), and Bible Study Sunday School) and the Mission and Evangelism Team volunteered to fund, prepare, and/or serve an evening meal every other month to 90-110 Arlington Life Shelter clients. This year, teams were able to return to preparing and serving the meal in the new ALS kitchen. The teams prepared or ordered the food for the meal. The ALS relies 100% on more than 250 churches and community organizations who provide all the meals needed for residents at the ALS for 365 days each year. Thank you to everyone who supported this outreach in 2023! If you are interested, please contact Katina Gifford, Manuel LeBlanc, or Suzie McCoy to discuss signing up to help with one of the six meals. As the shelter is able to

serve more individuals and families, our teams will need additional help from congregational members interested in this ministry.

#### **Arlington Charities**

FPCA continues to assist Arlington Charities with various needs annually, including funding and food donations. Arlington Charities is also a partner in the Mobile Food Bank and Thanksgiving Basket activities. FPCA members assisted by transporting donated food to Arlington Charities, and there are openings to assist by helping with pickup and deliveries.

#### **Carter Appreciation Events**

We were able to hold a Carter teacher appreciation event in August of 2023. In May, the team served muffins, yogurt, and bagels for the teachers. In addition, several congregation members helped to greet and encourage new Carter students as they arrived at Carter for the first day of school.

#### **Embrace Grace**

In 2023, the Mission and Evangelism Team recommended to Session a request to bring a new ministry to FPCA, called Embrace Grace. Embrace Grace was founded by Amy Ford, and its mission is to help churches be places of God's love for single women who find themselves with unexpected pregnancies. FPCA hosted its first 12-week class in Fall 2023. Three women made up our first cohort, and Mission and Evangelism was able to provide all class materials.

Volunteers were integral to helping the class be a success, including but not limited to Shina Heo, Diane Terwilliger, Talita Gottmann, Melina Pena, Yvette Fielder (interpreting), Katina Gifford, and James Gifford (childcare). Near the end of the course, FPCA also held a combined baby shower, made possible by the Hospitality Team and the entire congregation. In addition to the gifts bought and wrapped, we raised just over \$1,300 and were able to supply all baby items on each lady's list and more. The love of God truly surrounded each of these ladies and their babies. They were blessed with so much grace and a great way to start their parenting journey. Thank you to all who participated, and we look forward to hosting the next Embrace Grace class in the summer of 2024! Volunteers (e.g., class leaders, Spanish interpretation, possible transportation, childcare, and baby shower coordinators) will be needed, so contact Katina Gifford if God has placed this ministry on your heart.

#### **Trunk or Treat**

The Mission and Evangelism Team helped the Discipleship Team, Kyle Terwilliger, and a large number of volunteers with this event on Saturday, October 29. Lucia Bitner provided our games again in 2023, and volunteers from the Lamar women's basketball team, along with our youth, ran the games. The Fellowship Team cooked and served over 300 hot dogs, which were devoured in the first hour. Women's Bible Study gave out books to all the children attending. We had several trunks lined up for the families to visit and get candy. It was probably one of our largest Trunk or Treat events with an estimated 400 to 500 attending during the 2 hours. Once again, the large bubble stations were a favorite for many families who played and laughed while making huge bubbles fly through the air.

This was truly a church-wide event and supported community outreach. What a wonderful way to love our neighbors!

#### **Thanksgiving Food Baskets**

Members of FPCA continue to generously support this event. This year, we returned to having members gather food donations with some changes to the menu. We also continued to accept monetary donations. FPCA members donated 155 baskets and \$2,580. Arlington Charities uses the Thanksgiving baskets and monetary donations to distribute food for families in need.

#### **H.O.P.E. Tutoring**

H.O.P.E. Tutoring is a continuing program to provide free tutoring to children in grades 3 through 8 in a safe learning environment. FPCA hosted a site for tutoring for Arlington students on Tuesday evenings in the spring and fall semesters. In addition to supplying the facility, many church members volunteer their time to serve as tutors, and there are openings for more tutors when classes start in 2024.

#### Presbyterian Children's Homes and Services (PCHAS)

FPCA continues to support PCHAS through special offerings and direct financial contributions annually. Fortunately, FPCA was host to youth from the Itasca foster village at church and a lunch following worship on May 7. After lunch, the group attended a UTA baseball game.

#### Fred Kurz Memorial Scholarship

Our own Adrian Rodriguez was the 2023 recipient of the Fred Kurz Memorial Fund Scholarship. Adrian completed his studies at Fuller Theological Seminary where he earned his Master of Divinity (MDiv). FPCA is very happy to be able to assist Adrian as he pursues his call to the ministry.

#### Gifts of Hope

Gifts of Hope 2023 was a great success! This mission provides an excellent alternative gift market that offers a creative and caring way to honor friends, family members, colleagues, etc., through donations to a wide range of outreach organizations. "Shoppers" choose an organization, donate the amount specified, and then receive a card to give as a gift to friends or family. This program not only supports outreach organizations, but also seeks to offer a less materialistic option for gift giving. This year the program raised \$1,601 for gifts to support both local and international mission organizations. Donations will be given to World Vision, International Justice Mission, Voice of the Martyrs, Arlington Charities, H.O.P.E. Tutoring, and Presbyterian Children's Home and Services.

#### **Mitten Tree**

Members donated mittens, hats, socks, and other clothing items on and under the Mitten Tree. These items were collected and delivered to Arlington Life Shelter and Salvation Army.

#### **National Ministries**

#### **Special Offerings**

Several special offerings were held throughout the year: One Great Hour of Sharing, Pentecost Offering, Presbyterian Children's Homes Offering, and the Joy Offering.

#### **International Ministries**

#### **Brett and Marla Shideler, Wycliffe Bible Translators**

Brett and Marla have been with Wycliffe since 1993. Their current assignments find them working remotely from their home in the Pacific Northwest. Brett served with SIL International on the Global Human Resources Team in a Special Projects role. His primary focus in 2023 was supporting and working with members who find themselves impacted by unusual administrative events. SIL is a key partner with Wycliffe USA in Bible translation work around the world. SIL has over 6,000 members partnering with 1,347 communities that represent 897+ million people in 98 countries. Brett retired from Wycliffe during 2023. We celebrate this milestone with Brett!

Marla's assignment is with Wycliffe USA as an associate director and resource coordinator on the Care Team. It has her providing supervision for two resource coordinators as well personally supporting 30 families and unmarried Wycliffe members. Marla also oversees a team that is responsible for revising and editing "workflows" that document processes and procedures that are critical to providing care for Wycliffe members.

In financial and prayer partnership with Brett and Marla in 2023, FPCA is making a difference to 1.51 billion people, speaking 6,661 languages, who still do not have the full Bible in their first language and to 145 million people, speaking 1,892 languages, who are still waiting for translation work to begin. Your partnership makes the Shideler's Wycliffe ministry possible!

#### Matthew and Teresa Lee, Wycliffe Bible Translators

Matthew and Teresa Lee continue to serve as Wycliffe missionaries to Cameroon in 2023. Matthew supports Bible translation efforts through his work with language software. The team was able to restart in-person workshops this year, and these have been numerous and fruitful across the country for translation, literacy, and linguistics. Matthew was recently added as adjunct faculty to Dallas International University and will be remotely teaching a course on endangered language documentation in 2023. Teresa teaches kindergarteners (and sometimes preschoolers too!) of missionaries in Cameroon.

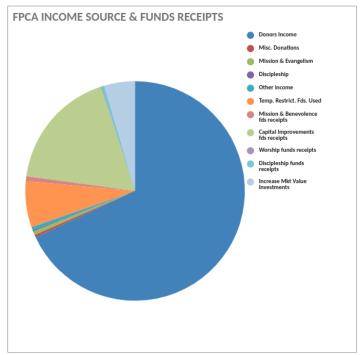

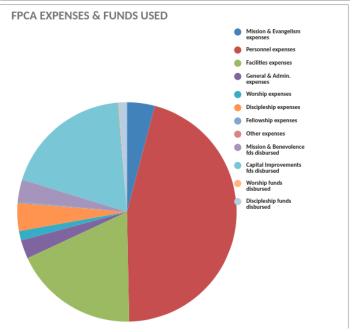
